

## Project Update - June 23, 2025

#### Larpenteur Avenue Closure Will Begin The Week of July 7th

- Larpenteur Avenue E will be closed between Beebe Road and McKnight Road starting the week of July 7th and continuing through early August, weather dependent.
- Traffic on Larpenteur Avenue will utilize the signed detour on White Bear Avenue, N St. Paul Road, and McKnight Rd N, outlined in the map below.
- For properties on Larpenteur Avenue and Winthrop Street N within the closure area: Local access will be maintained when possible. Access may be impacted during underground utility work, but crews will open access to local properties by the end of each workday.
- Project staff will be communicating directly with impacted properties in the closure area the week of June 23rd.

#### Public Infrastructure Work for the Week of June 16

- Utility crews continued storm sewer installation on Howard Street between Ivy Avenue and Montana Avenue.
- Roadway crews continued prepping the roadway base on Howard Street between Ivy Avenue and Montana Avenue, and Montana Avenue from McKnight Road to Howard Street.
- Grading crews finished prepping Winthrop Avenue between Hoyt Street and future Iowa Street for future private utility work.
- Utility crews began sanitary sewer work on Howard Street from Larpentuer Avenue to Montana Avenue.

#### Public Infrastructure Work Anticipated Week of June 23

- Utility crews will continue storm sewer installation on Howard Street between Ivy Avenue and Montana Avenue.
- Roadway crews will continue prepping the roadway base on Howard Street between Ivy Avenue and Montana Avenue, and Montana Avenue from McKnight Road to Howard Street.
- Utility crews will continue sanitary sewer work on Howard Street from Larpentuer to Montana Avenue, and on Winthrop Avenue from Ivy Avenue to Cottage Avenue.

#### 2025 Partner Work

- Habitat for Humanity will continue construction of their 147 mid-density affordable housing units this summer, with the first units coming for sale this year. For more information on housing at The Heights please visit: <u>https://theheightshousing.com/</u>

- Ever-Green Energy will continue the installation of their district geothermal energy system in The Heights. The aquifer thermal energy storage system will be one of the first in the state. - The Saint Paul Parks and Recreation Department is planning the development of a <u>5-acre park at The Heights</u> which will serve the community within and around The Heights Development.
- Private utility companies will continue to work within the site to build electric and

fiber-optic infrastructure to support the development.
