# Urban Design Workgroup

### Scope of Work

The Urban Design Work Group will collaborate with the Saint Paul Port Authority, influencing covenants that fall within the parameters of the City's Master Plan. Concepts to be discussed include aesthetic considerations relating to buildings, open spaces, trails, right of ways, and more. This group will also discuss opportunities tied to the neighborhood node.

## Work Group Structure

The committee will consist of six members, including Greater Eastside residents and subject matter experts. Residents will represent the wants and needs of their neighbors while subject matter experts will assist in solidifying a cohesive design.

#### 1. Work Group Team Leads (2)

The recommendation is to designate co-leaders for this Work Group. Together, they will structure meetings in partnership with the Saint Paul Port Authority and LHB. They will take the lead facilitating meetings, assigning tasks, and providing post-meeting summaries. Additional time will be needed between meetings to ensure adequate coordination.

#### 2. Committee Members (4)

Committee members share their ideas and opinions and come prepared to each meeting by reading all provided documentation and finishing assigned homework.

Ideal candidates will have a connection to the neighborhood and experience/passion around the concept of urban design. Members should have the confidence and communication skills needed to influence others and be able to represent the entire community, and not just their personal opinions. Committee members should represent differences in both thought and experiences while fostering an environment of inclusivity and collaboration. Transportation, translation, and childcare support should be available if needed.

### 3. Port Authority Role

The designated Port Authority leader will serve as a point person for the co-leadership team. This individual will manage meeting logistics and guide co-leaders through the process of setting goals for each meeting.

#### 4. LHB Role

LHB will provide technical guidance and materials for all scheduled meetings. Their contributions will be included as agenda items throughout the process.
